### REQUEST FOR DISTRICT SUPERINTENDENT'S DECISION ON A QUESTION OF LAW

Reverend Jean Tippit, District Superintendent of the Pensacola District,

Pursuant to ¶¶ 419.10, 2718.1, and 2718.2 of the *Book of Discipline* ("*Discipline*")<sup>+</sup>, I hereby submit to you in writing during the regular business of a church conference of the First United Methodist Church of Pace ("FUMC of Pace") in the Pensacola District my request for a District Superintendent's decision of the following question of law:

Whether the resolution for the disaffiliation of the FUMC of Pace from The United Methodist Church and its presentment to the church conference for a vote of approval along with such vote of approval are unlawful circumventions of the disaffiliation mandates, limited qualifications, and minimum requirements of ¶ 2553 of the *Discipline*; subvert the action of the 2019 Special Session of the General Conference; and therefore are null and void as actions that negate, ignore, and violate the provisions of the *Discipline*, in particular ¶ 2553, when:

1. Where the presenters and proponents of the disaffiliation referendum have failed to provide and establish:

(a) the actual and valid reasons for the disaffiliation of the FUMC of Pace, including facts and circumstances that support and are the basis for only the limited reason(s) of conscience mandated and specified in  $\P$  2553.1 permitted to justify the eligibility and qualifications of the FUMC of Pace to the limited right to disaffiliate under  $\P$  2553.1; and

(b) that the FUMC of Pace and its members are actually conscience bound to disagree, object, or not comply with:

(1) A change in the requirements and provisions to the *Book of* Discipline related to the practice of homosexuality or the ordination or marriage of self-

avowed homosexuals resolved and adopted by the General Conference in 2019 ["the 2019 amendments"], which are:

(i) ¶ 304.3: In particular, the amendment to footnote 1 of ¶ 304.3 that was amended to broaden the scope of relationships or activities that were encompassed in the definition of "self-avowed practicing homosexuals" who, under ¶ 304.3, are "not to be certified as candidates, ordained as ministers, or appointed to serve in The United Methodist Church."

The proposed disaffiliation resolution (which also pertains to the release of the connectional obligations by the FUMC of Pace under the Trust Clause of the Discipline) is actually and factually predicated upon paragraphs of the *Discipline* other than ¶ 2553, and therefore is improper as a matter of church law and is null and void because it "[subverts] . . . and circumvents the disaffiliation mandates and minimum requirements that the General Conference has set forth in Section VIII of Chapter Six in the *Discipline* [¶ 2553]. See Judicial Council Decision 1449 (Aug. 22, 2022).

3. The proposed disaffiliation resolution and its approval are predicated upon the "reason" and argument of the presenters and proponents that they cannot wait (and therefore the members of the FUMC of Pace should not wait) for the 2024 or other future General Conference of the UMC, and a their reliance "upon potential proposed legislation that might be considered at a future General Conference (such as those references that were made to the *Protocol for Reconciliation and Grace through Separation*)." Such future General Conference(s) and/or proposed legislation or future votes have "no bearing or effect" as a reason of conscience under Section VIII of Chapter Six in the *Discipline*, ¶ 2553, and therefore the resolution and any adoption of it are improper, null, and void as unlawful circumventions and subversions of the strict and limited requirements for eligibility and entitlement for the limited right of disaffiliation under ¶ 2553. See Judicial Council Decision 1449 (Aug. 22, 2022).

4. The presenters and proponents of the proposed disaffiliation resolution have failed to demonstrate and establish that the church conference of the FUMC of Pace on the ¶ 2553 disaffiliation vote was fairly and legally noticed to all of its professing members and that the vote will be and is validly, fairly, and legally being attained in accordance with ¶¶ 248, 246.8, and 2553.3 of the *Discipline*, including that, as mandated by the Standard Form of Disaffiliation Agreement required by ¶ 2553.4(a); the General Council on Finance and Administration (GCFA), and the rules and policies of the Alabama-West Florida Conference, the motion or referendum and ballot must:

(a) Specify that the vote was (a) "to disaffiliate from The United Methodist Church";

(b) Specify that the FUMC of Pace is only "allowed to exercise the limited right in  $\P$  2553 of the Book of Discipline to disaffiliate from The United Methodist Church only for its reason(s) of conscience under the conditions stated in  $\P$  2553.1"; and

(c) Identify and delineate the specific, actual, and truthful and substantiating facts and circumstances for reasons of conscience regarding a change in the requirements and provisions of the Book of Discipline related to the practice of homosexuality or the ordination or marriage of self-avowed practicing homosexuals as resolved and adopted by the 2019 General Conference, or the actions or inactions of its annual conference related to these issues which follow.

The noncompliance of these requirements in this instance "subvert[s] . . . and circumvent[s] the disaffiliation mandates and minimum requirements that the General Conference has set forth in Section VIII of Chapter Six in the *Discipline* [¶ 2553]"; it is therefore a null and void resolution under the *Discipline*. See Judicial Council Decision 1449 (Aug. 22, 2022).

### Bishop David Graves's Review of District Superintendent's Ruling in Response to the Request for a Decision of Law Made at the Special Called Church Conference of Pace United Methodist Church

After reviewing the facts of this request for a decision of law at the church conference held at Pace United Methodist Church on September 6, 2022, I concur with the ruling of the District Superintendent. Rev. Tippit was correct that for the reasons stated no rule of law was required when considering the eligibility portions of this request under the first three points of the request (see Judicial Council Decision 1422.). The fourth point under the request for a ruling of law submitted to the District Superintendent was whether or not there was a duly called church conference resulting in the vote to disaffiliate. Based on church communications before and during the special called church conference, including church bulletins, emails, newsletter and postcards as well as the resolution, eligibility requirements for disaffiliation and ballot presented during the church conference, attached as exhibits, the facts demonstrate the church conference was properly held in accordance with the Book of Discipline. The purpose of the called special meeting was clearly stated and the provisions of paragraph 2553 regarding limited gualifications were included in multiple communications and explained to church membership during the meeting. According to the District Superintendent, there were no expressions of confusion about the purpose of the meeting or eligibility requirements.

Based on the facts and documents presented to me and the paragraphs of the Book of Discipline and Judicial Council Decisions cited in the Request for a Decision of Law, I concur with the Decision of Law made by District Superintendent, the Reverend Jean Tippit, on September 19, 2022.

## Exhibit I

### District Superintendent's Ruling in Response to the Request for a Decision of Law Made at the Special Called Church Conference of Pace United Methodist Church

### Statement of Facts:

A special called church conference meeting occurred at Pace United Methodist Church ("PUMC") on September 6, 2022. The Senior Minister of PUMC requested the District Superintendent (the "DS") schedule the special called meeting following a vote of the PUMC church council on August 17, 2022. The purpose of the special called church conference was to discuss and vote on UMC's possible disaffiliation from the United Methodist Church ("UMC"). The DS conducted the meeting at which time a resolution was submitted to approve PUMC's disaffiliation from the UMC, pursuant to Paragraph 2553 of the *United Methodist Church Book of Discipline (the "Discipline")* (See Resolution at Exhibit 3.)

Prior to the special called meeting, notice thereof was communicated to church membership in multiple ways. Notice of the meeting was announced from the pulpit and published in church bulletins on August 21 and September 4 of 2022. (See copies at Exhibit 4), in the September Newsletter (Exhibit 5) and one or more postcards and emails to church membership (Exhibits 6 & 7). As shown in the Minutes of the special called church conference (Exhibit 8), the Disaffiliation Resolution and a proposed ballot to be used to vote thereon (Exhibit 9) were presented to those in attendance. The Eligibility Requirements for disaffiliation from the UMC pursuant to Paragraph 2553 of the *Discipline* (Exhibit 10) were read to those in attendance by the DS.

The postcard mailed to members in advance of the meeting advised members that the purpose of the meeting was to vote on disaffiliation (Exhibit 6). One or more emails sent to the membership by the Senior Pastor stated those attending the meeting would have the opportunity to vote on PUMC disaffiliating from the UMC. The email explained that paragraph 2553 of the Discipline provides the reasons a church may disaffiliate from the UMC and quoted section 1 of paragraph 2553 therein. (Exhibit 7). In addition to the DS reading the requirements of paragraph 2553 to the membership, the resolution and ballot submitted to memberships during the meeting referred to paragraph 2553 and quoted section 1 thereof. During the special called meeting, the Senior Minister requested a ruling on a Question of Law (the "Request") from the DS (Exhibit 2). In summary, the Request was submitted for a ruling of law on whether the resolution for the disaffiliation of PUMC from the UMC, its presentment to the church conference for vote and the approval thereof was an unlawful circumvention of the *Discipline* and the 2019 General Conference and in violation of the requirements of paragraph 2553 of the *Discipline*. The DS responded that she would rule within 30 days and this is that ruling.

### Analysis and Rationale.

I find that no ruling of law is required in response to paragraphs 1-3 of the Request because the Alabama West Florida Conference has determined that it is the policy of the Conference that it will not question "reasons of conscience" behind a church's decision to disaffiliate. If the church conference is held fairly and in conformance with the *Discipline*, and the resolution made at the church conference clearly articulates that the resolution proposes disaffiliation from the UMC pursuant to Paragraph 2553 of the Discipline, and contains language from paragraph 2553 that is then duly voted upon, the Conference policy is that it will not require further inquiry into the "reasons of conscience" behind the vote. See also Judicial Council Decision 1422.

However, it should be noted that the resolution presented to the special called church conference referred to and cited specific language from Paragraph 2553 (Exhibit 3). As shown in the Church Conference Minutes (Exhibit 8), the Eligibility Requirements for Disaffiliation pursuant to Paragraph 2553 (Exhibit 10) were read to those in attendance by the DS prior to the church vote. The ballot used to vote on disaffiliation refers to and cites critical language from Paragraph 2553 and states in part "the disaffiliation process from the United Methodist Church, under the terms of Paragraph 2553...". In an email to church membership announcing the special called church conference with the DS, the Senior Minister announced the purpose of the meeting was to vote on disaffiliation and therein he referred to and cited language from Paragraph 2553. (Exhibit 7). Given the discussion that took place at the special conference meeting and multiple documents discussed herein related to the vote, I know of no

reason to question the reasoning behind the vote at the special called church conference.

According to Paragraph 2553, a Local Church must provide documentation, to the satisfaction of the Annual Conference, which evidences the "result of the disaffiliation vote" taken at the church conference. The result of the disaffiliation vote at PUMC was 171 to disaffiliate and 55 to remain United Methodist. The attached Exhibits provide documentation believed to be satisfactory to meet Conference requirements.

Judicial Council Decision 1449, referred to in the Request concerns paragraph 2548 and is not applicable to this situation other than perhaps for the limited purpose to reinforce that church conferences must be called in accordance with paragraph 247-248 in the Book of Discipline. That was done in this case.

Regarding paragraph 4 of the Request, I rule that the special called church conference was a duly held conference in accordance with paragraphs 246 and 248 of the Book of Discipline. The Senior Pastor asked the DS to schedule a church conference following the vote of the church council on August 17, 2022. (Exhibit 7) The DS scheduled the church conference for September 6, 2022, in the PUMC sanctuary. The call for the church conference was announced from the pulpit, in church bulletins on August 21, 2022 and September 4, 2022 (Exhibit 4) and in the September Newsletter (Exhibit 5). Additionally, the church mailed post cards to church members which stated the purpose of the meeting was to vote on disaffiliation (Exhibit 6). Email(s) were sent by the Senior Minister (like the one attached as Exhibit 7) which advised not only the purpose for the special called meeting but advised further that the disaffiliation discussion and vote would be held in connection with paragraph 2553.

The purpose of the special called meeting and notices thereof were communicated multiple ways and times and the resolution, ballot and minutes reflect that the reason for the meeting and vote was the proposed disaffiliation from the denomination pursuant to paragraph 2553 of the *Discipline* for reasons of conscience related to the human sexuality issue stated therein. I was in attendance at the special called meeting, read aloud the provisions of Paragraph 2553 and heard the discussion that took place. I heard nothing to suggest there was any confusion or disagreement about the purpose of the meeting or any suggestion the meeting had not been properly noticed as a special called church conference. It is not the policy of the Conference to disregard or question the stated reason for a special called meeting or the reasons of conscience for disaffiliation, when the reasoning is clearly articulated as being pursuant to paragraph 2553 of the *Discipline* and documentation provided in connection with the disaffiliation supports the basis stated.

### Ruling:

Based on the above, I find that the PUMC special called church conference was properly noticed and conducted in accordance with the Discipline and that the resolution proposing that PUMC disaffiliate from the UMC pursuant to paragraph 2553 was properly approved by a vote of 171 to 55. I know of no facts to suggest the vote to disaffiliate is contrary to the requirements of paragraph 2553 or based on reasons other than those stated in the Resolution, ballot and other documents discussed herein.

(c) Identify and delineate the specific, actual, and truthful and substantiating facts and circumstances for reasons of conscience regarding a change in the requirements and provisions of the Book of Discipline related to the practice of homosexuality or the ordination or marriage of self-avowed practicing homosexuals as resolved and adopted by the 2019 General Conference, or the actions or inactions of its annual conference related to these issues which follow.

The noncompliance of these requirements in this instance "subvert[s] . . . and circumvent[s] the disaffiliation mandates and minimum requirements that the General Conference has set forth in Section VIII of Chapter Six in the *Discipline* [¶ 2553]"; it is therefore a null and void resolution under the *Discipline*. See Judicial Council Decision 1449 (Aug. 22, 2022).





### REQUEST FOR DISTRICT SUPERINTENDENT'S DECISION ON A QUESTION OF LAW

Reverend Jean Tippit, District Superintendent of the Pensacola District,

Pursuant to ¶¶ 419.10, 2718.1, and 2718.2 of the *Book of Discipline* ("*Discipline*")<sup>+</sup>, I hereby submit to you in writing during the regular business of a church conference of the First United Methodist Church of Pace ("FUMC of Pace") in the Pensacola District my request for a District Superintendent's decision of the following question of law:

Whether the resolution for the disaffiliation of the FUMC of Pace from The United Methodist Church and its presentment to the church conference for a vote of approval along with such vote of approval are unlawful circumventions of the disaffiliation mandates, limited qualifications, and minimum requirements of ¶ 2553 of the *Discipline*; subvert the action of the 2019 Special Session of the General Conference; and therefore are null and void as actions that negate, ignore, and violate the provisions of the *Discipline*, in particular ¶ 2553, when:

1. Where the presenters and proponents of the disaffiliation referendum have failed to provide and establish:

(a) the actual and valid reasons for the disaffiliation of the FUMC of Pace, including facts and circumstances that support and are the basis for only the limited reason(s) of conscience mandated and specified in  $\P$  2553.1 permitted to justify the eligibility and qualifications of the FUMC of Pace to the limited right to disaffiliate under  $\P$  2553.1; and

(b) that the FUMC of Pace and its members are actually conscience bound to disagree, object, or not comply with:

(1) A change in the requirements and provisions to the *Book of* Discipline related to the practice of homosexuality or the ordination or marriage of self-

Discipline at ¶ 2718.1 states: "1. The order of appeals on questions of law shall be as follows: from the decision of the district superintendent presiding in the charge or district conference to the bishop presiding in the annual conference, and from the decision of the bishop presiding in the annual conference, and from a central conference to the Judicial Council."

<sup>&</sup>lt;sup>1</sup> Judicial Council has ruled in Decision 1443:

One of the duties of a District Superintendent is to "interpret and decide all questions of Church law and discipline raised by the churches in the district, subject to review by the resident bishop of the annual conference," *Discipline* ¶ 419.10. When a written question of Church law is properly raised during a charge conference session, the District Superintendent is to make a ruling thereon, and the secretary is (i) to ensure that a copy of the request and the ruling thereon by the District Superintendent are included in the charge conference minutes, and (ii) that certified copies thereof are sent to the secretary of the annual conference to be heard as an appeal by "the bishop presiding in the annual conference," *Discipline* ¶ 2718.2.

avowed homosexuals resolved and adopted by the General Conference in 2019 ["the 2019 amendments"], which are:

(i)  $\P$  304.3: In particular, the amendment to footnote 1 of  $\P$  304.3 that was amended to broaden the scope of relationships or activities that were encompassed in the definition of "self-avowed practicing homosexuals" who, under  $\P$  304.3, are "not to be certified as candidates, ordained as ministers, or appointed to serve in The United Methodist Church."

(ii) ¶ 304.5: Prohibitions were added against approvals and recom-mendations by the district committee on ordained ministry and the Board of Ordained Ministry of persons who did not meet the qualifications in ¶ 304, including ¶ 304.3 (see *above*), and it specified additional instructions for the clergy session presiding bishops to rule that the unqualified candidate to be out of order and ineligible for the appointment.

(iii) ¶ 415.6: An amendment to prohibit bishops from consecrating bishops, from commissioning persons on the deacon or elders track, and from ordaining deacons or elders if any of them are self-avowed practicing homosexuals.

(2) Subsequent actions (such as complying with, implementing, or enforcing the 2019 amendments) or inactions (such as omissions, failures, or refusals to comply with, implement, or enforce the 2019 amendments) by the annual conference of the Alabama-West Florida Conference that are related to the change of requirements and provisions in the 2019 amendments noted above.

2. The proposed disaffiliation resolution (which also pertains to the release of the connectional obligations by the FUMC of Pace under the Trust Clause of the Discipline) is actually and factually predicated upon paragraphs of the *Discipline* other than ¶ 2553, and therefore is improper as a matter of church law and is null and void because it "[subverts]... and circumvents the disaffiliation mandates and minimum requirements that the General Conference has set forth in Section VIII of Chapter Six in the *Discipline* [¶ 2553]. See Judicial Council Decision 1449 (Aug. 22, 2022).

3. The proposed disaffiliation resolution and its approval are predicated upon the "reason" and argument of the presenters and proponents that they cannot wait (and therefore the members of the FUMC of Pace should not wait) for the 2024 or other future General Conference of the UMC, and a their reliance "upon potential proposed legislation that might be considered at a future General Conference (such as those references that were made to the *Protocol for Reconciliation and Grace through Separation*)." Such future General Conference(s) and/or proposed legislation or future votes have "no bearing or effect" as a reason of conscience under Section VIII of Chapter Six in the *Discipline*, ¶ 2553, and therefore the resolution and any adoption of it are improper, null, and void as unlawful circumventions and subversions of the strict and limited requirements for eligibility and entitlement for the limited right of disaffiliation under ¶ 2553. See Judicial Council Decision 1449 (Aug. 22, 2022).

4. The presenters and proponents of the proposed disaffiliation resolution have failed to demonstrate and establish that the church conference of the FUMC of Pace on the ¶ 2553 disaffiliation vote was fairly and legally noticed to all of its professing members and that the vote will be and is validly, fairly, and legally being attained in accordance with ¶¶ 248, 246.8, and 2553.3 of the *Discipline*, including that, as mandated by the Standard Form of Disaffiliation Agreement required by ¶ 2553.4(a); the General Council on Finance and Administration (GCFA), and the rules and policies of the Alabama-West Florida Conference, the motion or referendum and ballot must:

(a) Specify that the vote was (a) "to disaffiliate from The United Methodist Church";

(b) Specify that the FUMC of Pace is only "allowed to exercise *the limited* right in  $\P$  2553 of the Book of Discipline to disaffiliate from The United Methodist Church only for its reason(s) of conscience *under the conditions stated in*  $\P$  2553.1"; and

(c) Identify and delineate the specific, actual, and truthful and substantiating facts and circumstances for reasons of conscience regarding a change in the requirements and provisions of the Book of Discipline related to the practice of homosexuality or the ordination or marriage of self-avowed practicing homosexuals as resolved and adopted by the 2019 General Conference, or the actions or inactions of its annual conference related to these issues which follow.

The noncompliance of these requirements in this instance "subvert[s] . . . and circumvent[s] the disaffiliation mandates and minimum requirements that the General Conference has set forth in Section VIII of Chapter Six in the *Discipline* [¶ 2553]"; it is therefore a null and void resolution under the *Discipline*. See Judicial Council Decision 1449 (Aug. 22, 2022).

### Eligibility for Exercising the ¶ 2553 Limited Right of Disaffiliation

A local church is allowed to exercise the limited right established in ¶ 2553 of the *Book of Discipline* to disaffiliate from The United Methodist Church only for reasons of conscience under the conditions stated in ¶ 2553.1 which reads: "Basis – Because of the current deep conflict within the United Methodist Church around issues of human sexuality, a local church shall have a limited right, under the provisions of this paragraph, to disaffiliate from the denomination for reasons of conscience regarding a change in the requirements and provisions of the *Book of Discipline* related to the practice of homosexuality or the ordination or marriage of self-avowed practicing homosexuals as resolved and adopted by the 2019 General Conference, or the actions or inactions of its annual conference related to these issues which follow."

The following changes in the requirements and provisions of the Book of Discipline relating to the practice of homosexuality or the ordination or marriage of self-avowed practicing homosexuals were resolved and adopted by the 2019 General Conference:

(1) Amendment to ¶ 304.3: In particular, footnote 1 of ¶ 304.3 was amended to broaden the scope of relationships or activities that were encompassed in the definition of "self-avowed practicing homosexuals" who, under ¶ 304.3, are "not to be certified as candidates, ordained as ministers, or appointed to serve in The United Methodist Church."

(2) Amendment to ¶ 304.5: Prohibitions have been added against approvals and recommendations by the district committee on ordained ministry and the Board of Ordained Ministry of persons who did not meet the qualifications in ¶ 304, including ¶ 304.3 (see above), and specified added instructions for the clergy session presiding bishops to rule that the unqualified candidate to be out of order and ineligible for the appointment.

(3) Amendment to ¶ 415.6: Amended to prohibit bishops from consecrating bishops, from commissioning persons on the deacon or elders track, and from ordaining deacons or elders if any of them are self-avowed practicing homosexuals.

(4) Amendment to ¶ 2702.1(b): Amendment to footnote 1 of ¶ 304.3 (see above) affects the usage of the term "self-avowed practicing homosexual" in the list of chargeable offenses related to clergy (viz., "being a self-avowed practicing homosexual; or conducting ceremonies which celebrate homosexual unions; or performing same-sex wedding ceremonies ....")
