BISHOP'S DECISION OF LAW

DIGEST OF THE RULING

RE. Resolution #5 "A commitment to Grace in the Indiana Conference"

After reviewing Resolution # 5, Bishop Trimble declared that the resolution was properly before the body for consideration. "While the resolution accentuates affirmations and calls for grace, it does not make null and void any prohibition in the Book of Discipline. It doesn't change the wording or impact of the Book of Discipline." I have reviewed the request submitted by Rev. Chris Gadlage for a decision of Law.

In Conference session, Bishop Trimble acknowledged his Point of Order and heard Rev. Gadlage's claim that the resolution was more than aspirational and should be ruled out of order quoting "encouraging actions that ignore and violate the Book of Discipline." I have reviewed the various Disciplinary paragraphs and Judicial Council rulings listed in Rev. Gadlage's request.

At the time of our Annual Conference on June 11, 2022, I ruled that the resolution was properly before the body and belonged to the body for discussion and debate. I acknowledged that the Petitions and Resolutions committee was not all in agreement that this resolution was free from an interpretation that would deem it out of order. The final decision to put the resolution in the hands of the Annual Conference was the presiding Bishop's. Prior to voting, clarifying questions were asked and answered that speak to the questions Rev. Gadlage has raised.

STATEMENT OF THE BACKGROUND

Resolution #5 (attached) "... resolved that we shall support every church and clergyperson in our 13 conference who is seeking to faithfully serve God and their communities to the best of their abilities and in accordance with their deeply held, God-given convictions. We shall strive to honor and trust contextual expressions of ministry, including the decisions of clergy to choose which weddings they officiate and congregations to choose which weddings they host, so long as they are between two consenting, committed adults. We shall also embrace and encouragé God's call to ministry in diverse persons and will seek to not restrict God's calling solely on the basis of a candidate's sexual orientation or gender identity. Further, we shall respect the decisions of any who feel they cannot remain a part of the Indiana Conference in light of these commitments."

Bishop's decision was made that the resolution was properly before the Annual Conference, and with a written ballot vote was passed 380 for 332 against.

STATEMENT OF THE QUESTION OF LAW

Rev. Abel asked if the application of Resolution #5 is aspirational or if it would be considered binding as it relates to anything in the Book of Discipline? Rev. Jason Rice asked, "If Resolution #5 passed, would people still be able to file charges against same-sex marriage?

Bishop Trimble clarified that the resolution as written does not change any prohibition in the Book of Discipline or strip the rights of persons who may choose to file complaints. It also does not change in any way the conference process for handling complaints. The author of the resolution was invited to speak about the aspirational nature in which it was written. Rev. Mary Dicken confirmed the invitational spirit in which the resolution was written. "An invitation to take a posture of grace, to allow the Holy Spirit to move in and through the Church. There is no mandate that goes against our Book of Discipline."

It is Bishop Trimble's interpretation that this resolution allowed clergy and laity to speak openly about the mission of United Methodists in Indiana as it relates to "the mission of seeking, welcoming, and gathering persons into the body of Christ."

This was done in a very respectful, vulnerable, grace-filled, honest, and powerful way by three persons who spoke in favor of the resolution and three who spoke against it. The first person to speak was a 14-year-old youth, Lydia Jacobson.

It is Bishop Trimble's interpretation that the resolution does not change in any way the work of District Boards of Ordained Ministry or the Conference Board of Ministry. It does not have the power to authorize or permit those listed prohibitions, nor does it restrict the rights or obligations of those listed leaders in the request for Decision of Law.

God's call to Ministry is not under the purview of a Bishop, Annual Conference, or Board of Ordained Ministry. God Calls whom God Calls.

In the United Methodist Church, that call is tested, witnessed, and affirmed beginning at the local Church, and then and only then, licensing and ordination come through the bodies of the annual Conference.

DECISION OF LAW

The specific words "shall support," "strive to honor and trust," and "shall also embrace and encourage," are aspirational in nature to express ideals and opinions, which is precisely what this resolution does. Because the language of the resolution is clearly aspirational, it does not run afoul of the Book of Discipline. Indeed, Decision 1292 cited in the request for decision discusses that the term "support" as used in another resolution was aspirational and not in violation of the Book of Discipline. Further, the language "seek not to restrict God's calling on the basis of a candidate's sexual orientation" is close to saying it will not be considered. However, it is Bishop Trimble's ruling that this does not violate the Book of Discipline or Decision 1341 in that a celibate person can be advanced as a candidate no matter what that person's orientation is.

Again, after reviewing Resolution # 5, "A commitment to Grace in the Indiana Conference," Bishop Trimble ruled that the resolution was properly before the body and belonged to the body for discussion and debate.

SECTION 3: State below the rationale or reason for this petition/resolution.

We are called to do no harm.

With the postponement of the General Conference until 2024, we cannot wait to respond faithfully to the Gospel call of inclusion. In recent years, LGBTQ+ persons have heard a repeated refrain of, "Just hold on a little while longer, until General Conference in 2020." Then "... until General Conference in 2022." Continuing this pattern with more calls to wait for delayed inclusion and justice perpetuates harm against marginalized persons in our United Methodist Church, as well as does harm to our shared ministry and witness. Our current state is not sustainable. We must move forward in faithful, inclusive ministry now.

We are called to do all the good we can.

Since the Global Methodist Church announced its intent to launch in May 2022, and Bishop Trimble stated, in response to this news, his intent to work graciously with those who feel compelled to leave The United Methodist Church, we must also take intentional steps to shape our ministry in the Indiana Conference to do good in the wake of these developments. Just as we are making room for people of good faith and conviction to join another denomination, we must also graciously make room in our conference for those who have been historically and contemporarily excluded from full participation in the life of the church, so that we may be the church Christ calls us to be now and in the future.

We are called to stay in love with God.

Our primary focus as a church should be our mission to make disciples of Jesus Christ for the transformation of the world. The fractious history of our denomination on questions of LGBTQ+ inclusion over the past half-century has greatly impaired our ability to stay in love with God together. For the sake of our mission, we must move forward in ministry in a way that allows for all people to respond fully and faithfully to God's call on their lives.

R-5 A COMMITMENT TO GRACE IN THE INDIANA CONFERENCE Rule of Law Request

In accordance with Paragraphs 51 and 2609.6 of the United Methodist Book of Discipline (Discipline) and considering Judicial Council Decisions (JCD) # 886, 1201, 1292, 1340, 1343, 1344, and 1435; I respectfully ask and request a bishop's decision of law on the following questions regarding Resolution R-5 "A COMMITMENT TO GRACE IN THE INDIANA CONFERENCE", just adopted by the 2022 session of the Indiana Annual Conference:

- 1. Does any part of this resolution impermissibly discourage the enforcement of church law, or otherwise encourage or express support for actions that negate, ignore, or violate our church law, particularly church law prohibiting "self-avowed, practicing homosexual" clergy (Discipline ¶¶ 304.3, 2702.1.b) and "ceremonies which celebrate homosexual unions" (Discipline ¶¶ 341.6, 2702.1.b)? If so, is this resolution null, void, and without effect, in whole or in part?
- 2. Does this resolution authorize, permit, or encourage clergy in our conference to conduct or local churches in our conference to host "ceremonies which celebrate homosexual unions" or "same-sex wedding ceremonies"? If so, is all or part of this resolution null, void, and without effect, considering Discipline ¶¶ 341.6 and 2702.1.b?
- 3. Does this resolution prohibit, restrict, or discourage complaints from being filed, processed, valid bills of charges from being certified, or such complaints and charges potentially resulting in a church trial (after an unsuccessful effort for just resolution) and penalty for clergy who commit the chargeable offense of "performing same-sex wedding ceremonies" (Discipline ¶ 2702.1.b)? If so, is this resolution null, void, and without effect, in whole or in part?
- 4. Does this resolution discourage or prevent district committees on ministry or the board of ordained ministry, or the clergy session from making "the full examination and thorough inquiry into the person's fitness" (particularly Discipline ¶ 304.3) as a candidate for: (1) annual election as local pastor; (2) election to associate membership; (3) election to provisional membership; or (4) election to full conference membership in light of Discipline ¶¶ 635.2.h, 304.2, 304.3, 305, 306, 310 and JCD # 1343, 1344 or does the resolution discourage disapprovals of ministry candidates who may be otherwise qualified but who clearly do not meet the standards of Discipline ¶ 304.3? If so, is this resolution null, void, and without effect, in whole or in part?
- 5. Does this resolution encourage district committees on ministry or the board of ordained ministry, or the clergy session to approve ministry candidates who do NOT meet the requirement of Discipline ¶ 304.3 prohibiting the approval of any candidate who "openly acknowledges to a bishop, district superintendent, district committee of ordained ministry, Board of Ordained Ministry, or clergy session that the person is a practicing homosexual; or is living in a same-sex marriage, domestic partnership or civil union, or is a person who publicly states she or he is a practicing homosexual" in light of JCD #702, 708, 722, 725, 764, 844, 984, 1020, 1341? If so, is this resolution null, void, and without effect, in whole or in part?

Does this resolution in any way limit or restrict the rights or obligations of the bishop, district superintendents, counsels for the church, committees on investigation, trial courts, boards of ordained ministry, or district committees on ministry in our annual conference to fully comply with and uphold Discipline ¶¶ 304.1-3, 341.6, 362, 635, 2701, 2702, 2704, 2706, and 2711? If so, is any section of the resolution null, void, and without effect?

- 9.1 Before business began, Mark Fenstermacher thanked Bishop for his leadership as congregations consider disaffiliation. He asked Bishop to share his wisdom and guidance. Bishop stated his position is not a secret as evidenced in his episcopal address. He believes discernment is the first step and encouraged those considering disaffiliation contact their Conference Superintendent and utilize the resources on the INUMC website.
- 9.2 Resolution 5 A Commitment to Grace in the Indiana Conference (Dicken).

 Bishop has reviewed resolution and ruled it is properly before us for the body to debate. He added the resolution accentuates but does not prohibit the BOD. A 14 year-old spoke in favor of the resolution.

 Point of Order Chris Gadlage stated he believes the resolution violated the BOD citing many paragraphs. Bishop asked for all references in writing so that he may review them.

 Three individuals spoke against the resolution, and one person spoke for the resolution. Russ Abel then asked for a point of clarity asking if the intent of the resolution is that the application will be aspirational or binding. Bishop responded it is aspirational, not binding. Jason Rice requested more clarification on the enforcement of the resolution. Aleze Fulbright asked the writer of the resolution to speak to its intent. Mary Dicken stated, "the intent is invitational for us to engage with each other in a different way." Bishop then asked Shannon Stringer to pray before calling for the vote. Motion passed (380 for / 330 against)
- 9.3 Boy Scout of America Settlement Larry Whitehead had hoped to be able to bring a report on the resolution of the Court decision on the bankruptcy case of the Boy Scouts of America. However, the case is not yet settled. To date, there have been 152 claims of abuse in some way connected to United Methodist churches in Indiana. Larry concluded a desire to support the scouting ministry in our churches while assuring child protection policies and practices are in place in every church.
- **9.4 Protecting Our Children** Shannon Stringer shared the work of a team recently formed by Bishop Trimble for the purpose of protecting our child ren. The group had two assignments: 1. To review and recommend changes to the INUMC Child Protection Guidelines for all District and Conference events. The policy is available at inumc.org/protectingourchildren. 2. To develop policy and resources for churches to implement their own child protection guidelines. The expectation is that all churches will have an abuse prevention plan.
- **9.5 Camping Ministry** Julie Macy thanked Bishop and the Conference for their exceptional support during the past two years. She provided a history of the camping ministry beginning in 1923. There are currently seven facilities offering camping and retreats. The camps were closed in 2020 and operated at a 50% capacity in 2021. Yet, they finished 2021 with a deficit of \$65,732. The camps should be full in 2022, allowing the deficit to be overcome.
