Our relationships with ecumenical partners, made possible by the Interdenominational Cooperation Fund, enable us to witness together while respecting our unique traditions and distinctions. We also unite in creative responses to concerns that fall within The United Methodist Church's Four Areas of Focus, such as widespread poverty, economic injustice, HIV/AIDS, substance abuse and violence, and racism.

Additional examples abound. Here are a few:

- ECUMENICAL HIV AND AIDS INITIATIVE IN AFRICA, COORDINATED BY THE WORLD COUNCIL OF CHURCHES;
- JUST REBUILDING OF THE GULF COAST HURRICANE RECOVERY INITIATIVE, RELATED TO THE NATIONAL COUNCIL OF CHURCHES;
- Work against substance abuse and violence, spearheaded by the Pan-Methodist Commission

Through United Methodist gifts to the Interdenominational Cooperation Fund, such ecumenical endeavors foster justice, mercy and peace in God's world.

The fund also develops principled Christian leaders for the church and the world through the Young Ecumenist Program, the United Methodist Ecumenical and Interreligious Training network and the National Council of Churches' Young Adult Stewards Program. These initiatives teach leaders about ecumenical theology and practice through study, worship and fellowship.
