# **GCORR Equity Monitoring Report No. 8**

"For all who share life, a place at the table, revising the roles, deciding the share,

With wisdom and grace, dividing the power, for all who share life, a system's that fair.

And God will delight when we are creators of justice, and joy, compassion, and peace,

Yes, God will delight when we are creators of justice...justice and joy."

Consideration of petitions directly related to our budget started on Tuesday morning and will continue through Friday. Budgetary documents may appear as technical presentations of numbers, percentages, and columns. They present funds based on income and expenses, and this year they reflect significant reductions in projected available funds secondary to church disaffiliations and/or closures in the United States.

While numbers and calculations are prominent in these reports and petitions, our budgets are, in fact, moral documents imbued with human stories of worldwide ministries, missions, visions, and aspirations, best viewed through an equity lens.

Who will gain or lose resources? When viewing the proposed budgets for programs, agencies, missions, etc., think about the ministries that are provided by each. Think about who they are serving. Are their mission fields local, regional, and in what region worldwide? How many people depend on these programs for education, health, community building? How many staff members are in place and/or are required to maintain effective ministries that can respond to needs as they arise?

Whom and what do we prioritize in a proposed budget? In the Rev. Dr. Jerry Pillay's sermon on Tuesday morning, he repeatedly asked, "What is the church to do?" He goes on to say, "The church must stand with God, not the rich and the powerful," and as a prophetic voice in the world, "correct political, legal, economical, and ecological imbalances" through "justice, reconciliation, and unity." When deliberating on our budget, we are compelled to examine the recommended funds to identify what items are funded fully, partially, or not at all. We are inspired to gather our strength to speak with courage to "economic imbalances" that compromise ministry and missions, including those that are among our stated denominational priorities.

This brings to mind a verse from the late Bishop William Boyd Grove's hymn "Christ, the Church You Gave is Broken:"

Holy Spirit, come and bless us, give us a vision for our day. Give a vision large and mighty to your people now, we pray. Make us one now, make us one now, Spirit, come and make us whole, Spirit, come and make us whole.

The delegates engaged openly and respectfully, if not passionately, about petitions having possible financial impact. One presenter helpfully reminded all that we can hold two truths in tension. The United States base of the UMC is facing financial pressures and would benefit from some relief. At the same time, all regions of the denomination value connexionalism, connectional ministries, the partnership of the general agencies, and the blessings of special funds, such as Africa University and the Historic Black Colleges and Universities.

As Bishop David Bard concluded the afternoon plenary, he celebrated that the delegation is actively working to build God's beloved community and moving beyond many barriers.

The Rev. Dr. Pillay ended his morning message with this challenge: "The unity of the Church (United Methodist Church) is in your hands!" We will add: The strength and impact of the worldwide living connection is in your very capable hands.

## **GCSRW Monitoring Report, May 1**

On Monday evening, as the sun set over Charlotte, over 150 delegates and friends participated in the Service of Lament, Confession and Hope. It was an open apology for survivors who have been harmed by The United Methodist Church. We confessed our sin of silence and recommitted ourselves to developing safe and healthy churches that honor and protect the whole person.


Much of what was shared in the service of lament was also reflected in the message of Rev. Dr. Jerry Pillay, the General Secretary of the World Council of Churches, yesterday morning. We have been urged to listen for the voice of God, which calls us to address injustices like war, violence, hunger, effects of climate change, and abuse, which disproportionately affect women and children. We cannot be silent, we must stand for justice.

We joyfully witnessed and celebrated the installation of Bishop Tracy Smith Malone, the first Black woman bishop to serve as the President for the Council of Bishops! The first white woman elected to the episcopacy was Bishop Marjorie Matthews who was elected in 1980 to serve the Wisconsin Episcopal Area. The first Black woman was Bishop Leontine T.C. Kelly, elected in 1984, who served the California-Nevada Conference.

Though the worldwide membership of The United Methodist Church is over 50% women, of our active bishops, only 20 of the bishops are women and 40 are men. During this General Conference, 5 female bishops and 7 male bishops have presided over our work.

We celebrate our delegates and their deep passion for the work of The United Methodist Church. Of those who participated in yesterday's discussions from the floor, 38.3% were women, 61.7% were men. Let us continue to work towards discussions that express our diversity.

May we live into our faith as expressed in yesterday's hymn: "Make us one now, make us one now; For God's witness in our time, for God's witness in our time. Holy Spirit, come and bless us. Give a vision for our day. Give a vision large and mighty to your people now we pray."

### Rule 33. Consent Calendar

Calendar items are automatically placed on a consent calendar when the item has ten (10) or fewer votes against the prevailing position of the legislative committee. Rule 33(3)(a)

The are three different consent calendars:

- Consent Calendar A contains calendar items involving *disciplinary* changes for which the legislative committee recommendation is to *adopt*
- Consent Calendar B contains calendar items involving *non-disciplinary* changes for which the legislative committee recommendation is to *adopt*
- Consent Calendar C contains any calendar item for which the committee recommendation is to refer.

Calendar items with a minority report *cannot* be placed on any consent calendar. Items with financial implications or items dealing with the Constitution cannot be placed on Consent Calendars A or B, but they *can* be placed on Consent Calendar C because there would be no financial or constitutional implications.

#### Rule 33(7) Removing a Calendar Item from the Consent Calendar

Any twenty (20) delegates may have a Consent Calendar item removed by submitting a Consent Calendar Removal Request Form by 3:00 p.m. of the day the calendar item first appears in the *Daily Christian Advocate*. The form can be picked up from room 103 and returned to room 103. Reserve delegates may sign requests to remove items from the consent calendar only while seated as voting delegates.

Drawing upon the guiding principles of our theological tradition (including Articles of Religion, Doctrinal Standards, and our Theological Task), the commission shall examine our connectional structures and recommend adaptations and innovations to increase missional effectiveness that are at once simplified, sustainable, and relevant.

**Corrections to the Calendar** 

The membership of the Commission shall comprise 32 voting members, to be appointed as follows: 28 by the Connectional Table, including at least one layperson and one clergyperson from each jurisdiction and central conference (or regional conference); and 4 bishops from different continents by the Council of Bishops. The leadership of the Commission shall be shared among three Commission members: one bishop, to be selected by the Council of Bishops; and one clergyperson and one layperson, one of whom shall reflect the diversity of the church, at least a quarter of its members being under 35 at the time of their appointment. The membership shall include expertise in the areas of theology, ecclesiology, missiology, and organizational management. The Connectional Table shall provide staff support for the Commission.

The Commission shall coordinate with those creating the General Book of Discipline, as well as the General Boards and Agencies and other strategic entities within the UMC, and seek engagement from a wide variety of sources, with specific opportunities for input from lay and clergy members of the UMC. The first meeting of the Commission shall occur on or before December 1, 2024. Annual and Central Conference (or regional conference) sessions in 2025 shall include opportunities for representatives of the Commission to hear the aspirations of their delegates. The Commission shall present its report and any recommendations to the Connectional Table for distribution to the general church at least 230 days prior to the next session of the General Conference, be it called or regular.
